3. Identify areas requiring investigation, research and restoration in the field of environment.

Terms and Conditions

1. The headquarters of the Council will be at Chandigarh.
2. The terms of Council will be at Chandigarh.
3. The Council will meet two or three times a year.
4. The decisions will be arrived at by consensus and will be advisory in nature.
5. Official Members will draw TA / DA, if any, from their respective departments.Non-Official Members will draw TA/DA from the Haryana State Pollution Control Board as per Government instructions contained in Chief Secretary to Government, Haryana, U.O. Letter No.670-POL (4)-77, dated the 4th April, 1972 read with U.O. No. 10/16/80-POL (4), dated the 12th December, 1980 as modified form time to time.
